Facility reports 4/27/23 that the external investigation is ongoing, and no determination has been made at the time of this report. Phone call made 4/27/23 to Chris Butler of Millcreek. CACD Investigator Jennifer Harper had visited the facility today. A/V disclosed that it was all female staff who performed the search. A/V did not provide a name of the A/O. Email sent to Jennifer Harper 4/27/23 who granted permission for licensing to visit the facility and provided snapshot and ref# of complaint. Licensing phoned Jennifer Harper 4/27/23. Ms. Harper stated that the A/V stated that nothing sexual took place during the search, but that she (A/V) did not agree with the search. Ms. Harper stated that an A/O could not be named as A/V stated that no one person searched her (A/V) more than any of the others present. Facility visited 5/1/23. 4 staff were present during the search, Nurse Dana Stephens and direct care staff Sheena Hampton, Mona Heard and Katakawia Lowe. Ms. Stephens was not working during today's visit. The other staff were all present and interviewed today. stated that 4 female staff were present during search. stated that she was searched. She stated that staff were looking for a "vape pen". stated that she had removed all of her clothing but her shirt and bra. **Set and that she was "definitely** exposed" from the waist down. stated that she did not feel staff had done anything inappropriate during the search.
