Report Description: I wanted to inform you of an incident that occurred at The Centers (EMAC). On 5/22/2023, client [REDACTED] told a Centers? staff member that one of her peers, [REDACTED] tried to force her ([REDACTED]) hand down her ([REDACTED]) pants. [REDACTED] said she told [REDACTED] to ?stop? and [REDACTED] left the dorm room. [REDACTED] said [REDACTED] touched her inappropriately approximately two weeks ago, but she did not report it to staff out of fear [REDACTED] would harm her. This incident was reported to the [REDACTED], and the reported allegations were accepted (Referral # [REDACTED]). The guardians for [REDACTED] and [REDACTED] were notified about this incident. [REDACTED] is an Alaska DCFS placement at The Centers. [REDACTED] is a private placement at The Centers. [REDACTED] was placed on sexual precautions due to this incident. [REDACTED] and [REDACTED] will not be allowed on the same dorm moving forward. As always, please do not hesitate to contact me if you need any additional information.

Interim Action Narrative: [REDACTED] was called and call was accepted. The AO was placed on sexual precautions. Residents will not be allowed on the same dorm moving forward.
