The Peer proceeded to jump over the table to get to the Client [REDACTED]. The Client [REDACTED] and the Peer exchanged hits with closed and open hands. After the two were seperated by staff, the Client [REDACTED] became defiant throwing items and getting on top of tables. Client [REDACTED] threatened to elope and tried to break in the cafeteria window. Client [REDACTED] took his shoes, socks, and shirt off. Client [REDACTED] later took clothing and wrapped it around his neck. Staff removed clothing. Client [REDACTED] did not have any injuries. No pain noted. Client was placed on 60k focus, Assault precautions, Elopement precautions, and Suicide precautions.

Interim Action Narrative: Staff removed piece of cloth from the resident. He was assessed by nursing. Resident was placed on 60k focus, assault precautions, elopement precautions, and suicide precautions.

Licensing Specialist spoke with Ms. Waynette Banks, Program Director, regarding ELS Case #015121.

Licensing Specialist reviewed camera footage for ELS Case #015121 for licensing concerns. The provider reported incident took place in the dining room area, ratio 2:4. Licensing Specialist observed two (2) residents sitting down at the table and two (2) walking around the dining room area.

Licensing Specialist observed resident come across the table, jump on the table, jump off the table toward his peer, and the altercation began. Licensing Specialist observed staff separate the residents by taking them to different areas of the dining room. The resident broke free from staff and ran around the room toward his peer. Resident was seen running toward a corner of the dining room area that was off camera. Two (2) of the residents were removed from the dining room area into the day area, ratio 2:2.

Licensing Specialist observed resident jumping on the tables, turning flips, banging on the serving window, banging on the door leading to the nursing area, banging on the walks, and laying on the seal of the serving window and floor. At 3:51 pm, Licensing Specialist observed resident take off his socks and shoes and he continued to jump on the tables. Licensing Specialist observed staff what appeared to be talking to the resident. Resident was observed throwing his shoes at the serving window and banging his shoe against the window.

At 3:53 pm, Licensing Specialist observed resident what appeared to be meditating (yoga style) sitting on top of the table. Licensing Specialist observed resident walking around the dining room with his hands covering his ears, ratio 2:1. The other resident was in the nursing area. Resident was observed sitting in the floor where it appeared that he removed his shirt and placed it around his neck. Licensing Specialist observed staff around the resident and the shirt was removed.

Resident was observed grabbing a jacket and attempting to wrap it around his neck. Staff was observed removing the jacket from the resident. Licensing Specialist observed resident take a sock and attempted to put it around his neck. When staff attempted to take the sock from the resident he ran around the room. Licensing Specialist observed resident lay on the floor and the sock was removed by staff. Resident was observed with only his pants on. Licensing Specialist observed staff on her cell phone.

At 4:19 pm, Licensing Specialist observed the Program Consultant enter the dining room. Resident and Program Consultant left the dining room area and the other staff went to the day area.
