**NARRATIVE**

On April 15th, 2022, at approximately 1310 hours, I was dispatched to 161 Skunkhollow Road ( Little Creek Behavioral Health) in reference to a possible run away juvenile. Upon arrival in the area, dispatch advised JUV 1 left on foot and was located at 6 Brewer Road.

As I approached 6 Brewer Road, I noticed a young male in grey sweat pants and a grey shirt sitting on the front porch of the residence. JUV 1 advised he ran away from Little Creek Behavioral Health because he did not feel safe. JUV 1 advised at the health facility there was a lot of fighting and it made him uncomfortable as well as gave him flashbacks to memories of his parents. JUV 1 advised he was placed at Little Creek Behavioral Health on April 8th, 2022, and staff have also made him feel unsafe at the facility. JUV 1 advised he did not want to share names of people making him feel unsafe. JUV 1 advised staff have yelled at him, and threatened to put him in restraints when he gets into trouble. JUV 1 advised he was taken away from his family due to drug problems and separated from his two siblings who reside in North Virginia.



