Report Description: [REDACTED] Dob [REDACTED], she is private placement. [REDACTED] was sitting on the unit with [REDACTED] Falls (staff), when she start asking for [REDACTED] keys. [REDACTED] reached over and attempted to grab [REDACTED] keys that was on her lanyard around her neck. [REDACTED] was holding tightly attempting to prevent [REDACTED] from pulling her keys from her neck. As [REDACTED] was holding onto her keys, [REDACTED] is continuing trying to take [REDACTED] keys out of her hand. During this situation [REDACTED] is still sitting in her chair trying to deescalate the situation by speaking to [REDACTED] in a calmly manner. [REDACTED] was able to retrieve the key fob from the lanyard and scan herself off the unit. She goes down the stairs onto the boy's unit, walk down the hallway. Antionette Byrom (staff) tries to stop [REDACTED] from going out the door, but [REDACTED] is using her arm to push Antionette off. [REDACTED] then goes through the exit down by the classroom. Antionette followed her out the door. [REDACTED] jumped over the gate and went down the road. Sherika Williams (consultant), Stephanie McCraw (nurse manager), Adrianna Lockhart (nurse), and Tiara Falls (BI) arrived at the gate when [REDACTED] jumping over the gate. Stephanie McCraw (nurse manager) and Monica Young (teacher) followed client until she stopped on Fairpark and 22nd street. Stephanie (nurse manager) stayed with [REDACTED] until the police arrived to bring her back to the facility. [REDACTED] arrived to the facility around 410 pm.
