Primary Narrative By Steven Bass, 05/29/23 21:20

Battery 2nd

On 5-29-2023 at 1855 hours I, Deputy Bass, responded to the Youth Home located at 20400 Col Glenn Rd in reference to an active fight in progress. Dispatch advised that there were four juveniles fighting at two different locations, and that staff was not able to get them under control. Deputies Browning, Cawthon, Tucker, and I responded code to the Youth Home.

Deputies Browning and Cawthon arrived first, and began handling the situation at the main building. Deputy Browning advised Deputy Tucker and I to head to the "Rose House" at this location. Upon arrival, Deputy Tucker and I, made contact with a worker at the facility, Michael Stanfield, and two juveniles,

Stanfield advised that [redacted] were in a minor physical altercation, pushing one another, and throwing water and ice cubes. Stanfield stated that when he went to physically separate the two juveniles to prevent the situation from escalating, [redacted] kicked him in his groin.

Deputy Tucker spoke with [redacted] who stated that she and [redacted] had been arguing about tearing up each others property. [redacted] stated that they threw water and ice cubes at one another, and had been pushing each other. Deputy Tucker advised that there were no physical marks on [redacted] to suggest a major physical altercation had taken place.

I spoke with [redacted] stated that [redacted] had been tearing up hers, and other juvenile's property, and she threw water and ice at [redacted] stated that they started pushing one another, when Stanfield physically separated them.

Stanfield advised that he wanted to file charges against [redacted]. Stanfield advised that the right side of his scrotum was red, and starting to bruise. Stanfield showed me his inner thighs, and I observed redness/swelling on both his right and left inner thigh. Stanfield refused medical attention. I photographed Stanfield to add to the report.

I contacted the on-call Juvenile Intake Officer. I advised him of my charges, and the situation with the . Juvenile Intake advised to issue a court date of 7-20-2023 at 0900 hours at Pulaski County juvenile Court. I completed an ADR with the charge of Battery 2nd - Certain Victims. I explained the court date to and Staff, and had a staff member sign the ADR. I provided copy of the ADR to staff, to be placed with her file at the Youth Home.

Fight

On May 29, 2023, I, Deputy M. Cawthon Jr., was dispatched to 20400 Colonel Glenn Road in reference to a fight that broke out at the youth home. Upon arrival, I spoke with Mr. Terrence McDaniel and Ms. Ebony Galmore who stated several of the girls in the home had a fight and they had to separate them all in order to gain control at the home. The girls involved in the fight were

All of which admitted to hitting someone. However, only _____ suffered from minor injuries and were cleared by the on staff nurse, Ms. Ebony Galmore. I spoke with Mr. McDaniel and he advised they have methods to separating the girls and sending off the instigators _____ and _____. All of the girls appeared to be under control at the time and I allowed the staff to handle the situation in house due to their protocols. The staff also stated they would notify the parents of all the girls about the incident.

Follow up information

On 05/29/23 at approximately 18:51 hours, I arrived to a disturbance involving several juveniles. I spoke with each individual juvenile and got their story. I did not see any major or life threatening injuries on any of the juveniles and I did not witness any of them causing harm to anyone. I spoke with the staff members and was advised that there were steps in place for placement of juveniles in these situations and that the two instigators _____ and _____ would be transported this same evening because they started both fights. I did not witness any of the fights and they were misdemeanors that did not occur in my presence. Each individual juvenile admitted to participating in a fight in some way or another. I simply assisted the staff with keeping them under control and reporting the incident for documentation purposes.
