(Perimeter of the Ozarks.) While I was in route, I was advised through Springdale dispatch that the caller needed to file a report for an assault on an employee. The suspect was described as a 13-year-old female. The caller stated that while the staff was attempting to get the child into a unit, the child was kicking an employee and was punching the employee in the face. The caller stated that this altercation happened around 5pm today. When I arrived on scene I spoke with the caller. She identified as Erica Love (B/D DOB 02/28/1991). She stated that one of their residents was refusing to go back to her unit and was trying to break out of the facility. The nursed called for the staff to try and help her back into the unit. This is when Erica and another staff member were trying to escort to her unit and she was kicking them. When they arrived at the room, wrapped her legs around Erica's legs. Erica then raises her arms to disengage with When Erica let go of she got up and charged at her. The staff then eventually were able to get in a restraint. threated to kill Erica during this was given a shot of some kind of medication and she calmed down. I contacted WCJDC and they advised that they would not be detaining due to her medical situation. They advised that they thought it would be unsafe to keep because they don't have any medical trained staff in the Juvenile Detention Center. was given the intake date of 06/21/2023 at 1100am at 123 N College. I gave this information to Erica and she said she would pass the information along Intake officer Kelly with JDC stated she would be attempting to contact DHS worker tomorrow. I have no further information at this time.
