Arrest Notes - 23-A01171

On June 13th, 2023 at 2:52 AM, Officers made contact with a juvenile [REDACTED] in the parking lot of the police department. That [REDACTED] was identified as arrestee [REDACTED]. Dispatch did confirm that [REDACTED] was entered into NCIC / NIC #M177426565 as a runaway juvenile earlier in the day on 06/12/2023. [REDACTED] did admit that he was out with Officers earlier and lied to them about [REDACTED] name not being [REDACTED].

[REDACTED] was placed into custody and transported to Crittenden County Juvenile Detention Center where [REDACTED] was advised that [REDACTED] charges are Disorderly Conduct and Obstruction of Governmental Operations for lying about [REDACTED] name to Officers. At the time of booking, Juvenile booking officers could not get in touch with a Juvenile Intake Officer to notate what they advise. At this time [REDACTED] will be held until further notice until an intake officer can instruct further. I did advise booking officers the situation so they could explain it to an intake officer.

On June 12, 2023 at approximately 2:30 p.m., I, Officer Kimbrough 271, responded to Perimeter Behavioral Health, 600 N 7th St, in reference to a runaway complaint, [REDACTED]. Dispatch gave a description of the juvenile before responding to the scene.

Officers located a [REDACTED] matching that description at N 4th and Thompson, but when asked [REDACTED] name [REDACTED] denied being [REDACTED]. I relocated to Perimeter where I spoke with the complainant, Clentary Stokes. Stokes advised that she had just made it back to the facility with [REDACTED] from being out for the day when she heard [REDACTED] strapping down [REDACTED] shoes. As soon as she came to a stop, [REDACTED] jumped out of the vehicle and ran across the field towards N 7th St. Stokes gave a better description of [REDACTED] and I asked officers if [REDACTED] matched that description to which I was advised
