**Description:**

On June 13th approx. 0900 hours, I made contact with CACD Investigator Logan with State Police and we scheduled to go to Perimeter at 1:30 to interview the victim, [REDACTED].

Upon arrival, Logan did a forensic interview in the conference room at Perimeter and the following is his narrative of the interview:

[REDACTED] was interviewed by Inv. Logan Woynaroski at Perimeter Behavioral Health in Springdale. Detective Hunter Helms and ASP Intern Allison Atkins observed.

After building rapport, [REDACTED] advised Woynaroski she was in foster care. [REDACTED] advised Woynaroski that something had happened with her former roommate [REDACTED] and her former roommate [REDACTED] refused to tell Woynaroski any details aside from what happened with [REDACTED] occurred more than once, but less than five (5) times, and what happened with [REDACTED] occurred one time. [REDACTED] advised these incidents occurred in the "back rooms" of the units. [REDACTED] would only say "they raped me", and when asked what "rape" meant, [REDACTED] said "sexual things".

[REDACTED] refused to acknowledge the body safety diagrams.

No further disclosures of abuse were made.
