Assisting Officers: Sgt. M. McKee #229, Ofc. D. Little #290, Ofc Z. Jones #253,

On June 30. 2023 at approximately 7:26 PM, I, Officer J. Clark #275, made scene at 2050 East Broadway Avenue (Big Star East) to assist other officers with a shooting investigation.

While on scene, I made contact with [REDACTED] (arrestee). While interacting with [REDACTED] I observed him to make several furtive movements towards his waistband and I noticed a slight bulge in that area. Officer D. Little #260 asked [REDACTED] if he had a firearm on him and [REDACTED] stated that he had multiple. The firearm was then removed from [REDACTED] and I attempted to detain him in handcuffs so that Officers could safely check the rest of his person. Upon attempting to place [REDACTED] in handcuffs, he stated that he was not going to comply and pulled away from me and started to assume a fighting stance. I then pushed [REDACTED] chest against of the front of a marked patrol unit and struggled with him, at which time he threw back his left elbow and struck me in the face causing my lip to bleed. Officer Z. Jones #253, Officer D. Little #290, Sgt. M. McKee #229, and myself were then able to safely secure [REDACTED] in handcuffs.

[REDACTED] was then transported to the West Memphis Police Department where he was interviewed by CID in relation to the shooting incident, and then I transported him to the Crittenden County Detention Center where he was advised of his court date and time.
