SHE SAID THAT SHE DIDN'T KNOW IF IT WAS BROKEN OR NOT BUT SHE WAS BEING DISCHARGED WHEN I ARRIVED. I ADVISED MS. MARTIN THAT IT WOULD BE CONSIDERED A BATTERY 3RD AND WARRANTS COULD BE OBTAINED. THE GRANDMOTHER WAS NOTIFIED VIA COMMUNICATIONS.
