-nurse Events Leading: Pt fell off her bed on Saturday. She was taken to urgent care yesterday, 7/27, where the LPN examined her and said it was swollen, bruised, and needed to be x-rayed. We were sent to another urgent care to get the x-ray but was told we had to go somewhere else. Due to it almost being 7pm, staff decided to take her the next day. She was taken to another urgent care where they said the "x-ray tech was limited" and they couldn't do it there. It was finally decided that she go to the ER. She was x-rayed and examined, it was not fractured, just badly bruised. Nursing Assessment date/time: 07/28/23 1:12pm: Patient presents at nurse station after returning from Arkansas Children's Hospital. Per collaborative report with staff and nurses patient was sent to urgent care yesterday and the treating practitioner endorsed that the patient lower back was tender and discoloration noted and advised having an x-ray to be performed of the coxxyx but they did not have access to x-ray at this site. Staff attempted yesterday to visit alternate site and was informed they would not be able to se her for an x-ray then. Patient was taken to a third urgent care site and was informed they would not be able to assist with x-ray also and orders were received by youthhome practitioner to transport the patient or AR Children's hospital for evaluation. Diagnosis was provided From AR children ER and X-rays were unremarkable. Provider at AR Children's advised ice or heat therapy for 15 minutes 3-4 times a day, use of a donut pillow while sitting, and Alternate Tylenol and Ibuprofen for pain as needed. Patient is to follow up with PCP if not improving after 1 week. Pt complaints of current pain and Tylenol provided. Pt instructed to reduce activity and not push herself and rest her injury as needed. Guardian was notified on 07/28/23 at 1:30pm by the nurse.

Interim Action Narrative: Resident was taken to urgent care for further evaluation and the emergency room for x-ray.
