Findings Description: The air conditioning was not working properly in 2 classrooms. Store Services repair company has been called out to address the concerns. Visit by Store Services were on 5/15 and 5/17 to fix the problem. The complaint is UNFOUNDED based on the fact that the Agency was aware and had contacted a repair company. Until the repairs are made, classroom 5 or the dorms will be utilized.

Program Manager Litzsey spoke with CEO Lockhart concerning a complaint that the air conditioner in the school classrooms was not working and the classrooms were hot. CEO Lokchart stated that the air conditioner was not all the way out, but 2 classrooms were affected. Building manager Thaddus Spranggings was called in and provided the following information.Store Services heat/air repair was out on 5/15/23 and again today 5/17/23 and planned to return later that day to fix the problem. On 5/15/23, the temperatures were up and went down. Part of the Store Services repairs were the IT room and the temperatures. CEO Lockhart stated that there is an extra classroom or class could be held on the units. Both have utilized in the last week. Upon checking the classrooms, both classrooms on the right side of the hall were warm in temperature. The first room on the right was empty at the time, the residents were at lunch and taking a break. The second room on the right has residents and staff. A fan was blowing the in room but the temperature was very warm. After the walk through of the school, the residents in the 2 classrooms on the right were relocated.

The following information was obtained from interviews. Staff 1 stated the air was out since last Thursday, the classrooms were hot but not unbearable. Staff 2 stated the air was not out on their side of the hall, but it was out in the SRU classroom. Staff 3 stated the air was out last Wednesday, the kids stated in the classroom while they worked on it. Staff 4 stated the air was out a couple of days last week and the temperature got up to 80 degrees on the thermostat. Staff 5 stated they had noticed any changes in the temperature in the classroom.

During the walkthrough of the units, bedroom 104 had shorts that had drawstrings in them (removed by CEO).
