

Regulation Not Applicable: Regulations Not Correctable: Narrative: Facility visited 6/14/23 in response to a complaint on 5/24/23 that client was sexually assaulted by client interviewed. reported that this incident happened "about a month ago...during the day...while staff were in the dayroom...twice in one reported that this did not happen at any other time. reported that each time took "about 15 minutes". reported that at no time during these incidents did staff check on his room. When asked how often staff checked on him in his room "not often". stated that he felt comfortable talking to staff if he ever felt unsafe. interviewed. stated that he understood there was an "accusation" adding that he has never done anything sexual with stated that he is not comfortable with talking about anything sexual with or any other male peers. staff checked on him and in their room "about every 15 minutes". ever felt unsafe. Chris Butler of Millcreek reported that after client first reported this to staff he was moved from Magnolia Hall to Tiger was assigned a room by himself with precaution of no roommate.Client was already and remained on Close Observation and Elopement Precaution which were initiated 5/8/23 for 30 days.
