NARRATIVE

OFFICERS MADE CONTACT WITH THE COUNSELOR MS. GREEN (VICTIM) AT THE CENTERS FOR YOUTH AND FAMILIES. SHE STATED WHILE DOING HER REGULAR COUNSELING WITH THE JUVENILE SUSPECT, THE JUVENILE GOT MAD AT HER AND PUNCHED HER IN HER STOMACH, SHE SAID SHE PREVENTED THE JUVENILE SUSPECT FROM BITING HER, BUT THE JUVENILE SLAPPED HER ON HER HEAD. SHE SAID THE SUSPECT WAS OUT OF CONTROL AND SHE HAD TO GET SECURITY TO SUBDUE HER AND PUT HER INTO CONFINEMENT. SHE SAID DUE TO HEPA LAWS, SHE CANNOT GIVE ANY DATE OF BIRTH AND THE MEDICAL DIAGNOSE. I ADVISED MS. GREEN TO SPEAK WITH THE JUVENILE PROSECUTING ATTORNEY'S OFFICE. THERE WERE NO VISIBLE INJURIES AND MEDICAL WAS REFUSED. ADDITIONALLY, MS. GREEN SAID THE SAME SUSPECT PUNCHED HER IN EYE ON MONDAY BUT, DID NOT WANT TO REPORT THE INCIDENT. BWC WAS IN USE.
