PRTF On 08/02/23 [REDACTED], [REDACTED], Parent Custody, DOB [REDACTED]) was sitting down in a chair near the water cooler when a peer ran up and pushed [REDACTED] out of his chair and causing him to obtain a laceration to the left side of his head. The staff intervened and separated the patients. The supervisor and nurse were notified. The staff will continue to monitor. The nursing report indicated pain and the injury was a 2cm laceration to the left side of the scalp. [REDACTED] was sent to the Dallas County Medical Center and received staples to his head and released back to Millcreek of Arkansas. [REDACTED] will follow up with his PCP. Dallas County Medical has not released the medical report.

Phone call made to Chris Butler of Millcreek who stated there is no camera footage of this incident. Visit scheduled for 8/4/23. Facility visited 8/4/23 in response to facility reported incident that client [REDACTED] was pushed by a peer requiring emergency medical attention, staples to head. No video was available of this incident. [REDACTED] was interviewed. [REDACTED] stated that client [REDACTED] pushed him out of a chair for no reason and that he had to go to the hospital and get staples. [REDACTED] showed staples on the back of his head. [REDACTED] stated that client [REDACTED] picks on him sometimes. [REDACTED] stated that it took "about 5 seconds" for staff to make sure he was ok. When 5 seconds was demonstrated to [REDACTED], he replied "quicker than that...right away...Mr. Bruce made sure I was ok". [REDACTED] stated that he feels safe at Millcreek and feels comfortable speaking to staff if he feels unsafe. [REDACTED] stated he felt that staff do everything they can to keep him safe. Millcreek Staff Kelly O'Brien, Supervisor over Rock Hill where the incident occurred consulted. Ms. O'Brien stated that other living units house older, larger males who could be a threat to [REDACTED]. Close Observation of client [REDACTED] was discussed. CEO Ben Beasley stated that client [REDACTED] would be placed on Close Observation. It was determined that client [REDACTED] should remain at Rock Hill cottage for optimum safety.
