NARRATIVE

OFFICERS RESPONDED TO THE METHODIST CHILDRENS HOME (2002 S FILLMORE) IN REFERENCE TO A BATTERY REPORT

MR. PEARSON AND MS. FALLS ADVISED THAT THEY HAD BEEN ATTACKED BY BOTH JUVENILE 1 AND JUVENILE 2.

JUVENILE 1 FIRST ATTACKED MR. PEARSON ON JULY 7TH, 2023. MR. PEARSON ADVISED THAT JUVENILE 1 STRUCK HIM AND THEN PULLED HIS HAIR FROM THE BACK REPEATEDLY. MR. PEARSON ADVISED THAT THE WAY IN WHICH JUVENILE 1 PULLED HIS HAIR CAUSED INJURY TO HIS NECK THAT REQUIRED PHYSICAL THERAPY.

ON AUGUST 15TH AT APPROXIMATELY 1600 HOURS, JUVENILE 2 ATTACKED MR. PEARSON WITH A CHAIR TO THE BODY AND THEN PROCEEDED TO KICK HIM ON THE "PRIVATES". MR. PEARSON ADVISED HE HAD TO CORRECT JUVENILE 2'S BEHAVIOR AFTER JUVENILE 2 EXPOSED HIS GENITALS AND MADE SEXUAL COMMENTS AND GESTURES TOWARDS OTHER STAFF MEMBERS.

JUVENILE 1 ATTACKED MR. PEARSON ONCE AGAIN ON AUGUST 15TH AT APPROXIMATELY 1730 HOURS. THIS TIME IT WAS BY "STABBING" HIM WITH A PEN TO THE LEFT ARM. MR. PEARSON SHOWED OFFICER AN INJURY TO HIS LEFT UPPER ARM CONSISTENT WITH BEING JABBED WITH A PEN. IT APPEARS THAT THE PEN BROKE THE SKIN BUT DID NOT PENETRATE ANY FURTHER.

MS. FALLS ADVISED THAT SHE WITNESS THE ATTACK AND SHE ATTEMPTED TO TAKE THE PEN AWAY FROM JUVENILE 1 BY REACHING FOR IT WHILE STANDING BEHIND JUVENILE 1. MS. FALLS ADVISED THAT JUVENILE 1 THEN TURNED AROUND AND STRUCK HER ON THE FACE, CAUSING IT TO BLEED. MS. FALLS ADVISED THAT JUVENILE 1 THEN DROPPED TO THE GROUND AND PROCEEDED TO BITE HER LEG. MS. FALLS SHOWED OFFICERS AN INJURY CONSISTENT WITH A BITE MARK TO HER LEFT UPPER LEG.

MR. PEARSON ADVISED THAT THERE HAVE BEEN SEVERAL OTHER INCIDENTS BETWEEN JULY 7TH AND AUGUST 15TH, BUT THESE TWO WERE SIGNIFICANT ENOUGH THAT HE FELT IT WAS NEEDED FOR HIM TO FILE A POLICE REPORT FOR HIS AND THE OTHER STAFF MEMBERS SAFETY.

MR. PEARSON AND MS. FALLS ARE CARETAKERS AT THIS FACILITY (METHODIST CHILDRENS HOME). METHODIST CHILDREN HOME IS A RESIDENTIAL TREATMENT FACILITY.

BOTH JUVENILE 1 AND JUVENILE 2 SUFFER FROM NEUROLOGICAL AND PHYSIOLOGICAL DISORDERS.

DHS HAS CUSTODY OF BOTH JUVENILE 1 AND JUVENILE 2. MAJOR CRIMES WAS NOTIFIED AND AT THIS TIME IT IS NOT CLEAR THAT THE FACILITY AND THE WORKERS MEET THE REQUIREMENTS FOR THE CHARGES TO BE ENHANCED TO FELONIES.

OFFICERS ADVISED MR. PEARSON AND MS. FALLS ON HOW TO OBTAIN A WARRANT IF THEY CHOSE TO DO SO.

OFFICERS PROVIDED MR. PEARSON AND MS. FALLS WITH AN INCIDENT NUMBER CARD.

MVR AND BWC WERE IN USE.
