PT was walking by the d-zone toward her designated class, while waiting to enter the classroom, her peer touched her inappropriately. The date of the [REDACTED] report was 8/17/2023 at 12:13 PM. Call was accepted for investigation.

Interim Action Narrative: AR [REDACTED] called and call accepted. Residents were placed on peer limit and AV was moved to a different classroom.

Maltreatment Narrative: A peer touched resident inappropriately.

Licensing Narrative: Licensing Specialist reviewed complaint for licensing concerns. Licensing Specialist will inquire about safety precautions. Licensing Specialist will follow-up on investigator and referral #. Licensing Specialist informed there is camera footage. 8/21/2023, Licensing Specialist reached out to facility to schedule a time to review camera footage. Licensing Specialist will pick up flashdrive with camera footage on 8/22/2023. Licensing Specialist inquired about the investigator. 8/22/2023, Licensing Specialist picked up flashdrive and will contact investigator for permission to contact the facility. 8/23/2023, Licensing Specialist received permission to contact facility regarding incident. Flashdrive

was given to IT to scan for viruses. 8/29/2023, Licensing Specialist received flashdrive from IT. 9/1/2023, Licensing Specialist unable to review camera footage on flashdrive due to not having permission. Licensing Specialist will follow-up with IT. IT was unable to resolve the issue, Licensing Specialist will have IT to look into the issue on 9/5/2023. 9/6/2023, Licensing Specialist reviewed camera footage. 9/18/2023, Licensing Specialist reached out to Investigator Pifer for an update. 9/21/2023, Licensing Specialist contacted Investigator Pifer for an update via telephone. The phone rung and went silent. Licensing Specialist send an email. Investigator Pifer informed Licensing Specialist that referral is still open. 9/29/2023, Licensing Specialist reached out to Investigator Pifer for the status on this referral. Investigator Pifer informed Licensing Specialist that case was closed, unsubstantiated.

Licensing Specialist observed a staff member walk out a room with residents walking behind. After the group of residents exited the room the other residents entered.

Before entering the room, Licensing Specialist observed what appeared a peer touching resident on her back area. When the group was entering the room, Licensing Specialist observed two (2) staff members walk down the hall and one staff member standing by the door while residents walked through the door.

Licensing Specialist is not prepared to leave a finding at this time.
