Interim Action Narrative: AR hotline called and call accepted. Residents were placed on 6 ft. peer limit from the accused.

Maltreatment Narrative: Residents [REDACTED] and [REDACTED] accused resident [REDACTED] entering their bedrooms and touching them inappropriately.

Licensing Narrative: Licensing Specialist reviewed complaint for licensing concerns. Licensing Specialist will inquire about witness statements, safety plan, late reporting, and/or nursing notes. Licensing Specialist will follow-up on the assign investigator. 9/8/2023, Licensing Specialist informed residents involved were placed on 6 ft. peer limit

with the accused. One resident attempted to tell staff but staff did not understand that it was touching. Staff member received disciplinary action. Licensing Specialist informed that resident [REDACTED] bedroom was moved and resident [REDACTED] is no longer in class with [REDACTED]. It was reported that there are no witness statements. 9/11/2023, Licensing Specialist inquired about the referral number provided. Licensing Specialist provided with referral numbers. 9/12/2023, Licensing Specialist informed of investigator. Licensing Specialist reached out to investigator for permission to contact the facility. 9/13/2023, Licensing Specialist received permission to contact the facility. 9/14/2023, Licensing Specialist informed by Investigator Wilson that resident [REDACTED] had been interviewed but not [REDACTED] due to him having covid. Licensing Specialist inquired again about late reporting. Licensing Specialist received an email with correspondence on when the hotline was submitted and accepted. 10/5/2023, Licensing Specialist followed-up with Investigator Wilson for an update. Licensing Specialist informed that referral is still pending. 10/16/2023, Licensing Specialist followed-up with Investigator Wilson for an update. 10/19/2023, Licensing Specialist informed referral found unsubstantiated.
