Report Description: On 8/31/2023, client [REDACTED], DOB: [REDACTED] was punched in the nose by a peer. [REDACTED] had an immediate nosebleed. Nursing applied gauze to the nasal septum and pinched it to stop the bleeding. She was sent to ACH ER for further evaluation. [REDACTED] returned to The Centers at approximately 1815 with a diagnosis of an abrasion and swelling of the nose. No broken nose or deviated septum was reported. [REDACTED] is a private placement at The Centers and her guardian was notified about this incident. As always, please do not hesitate to contact me if you need any additional information.

Interim Action Narrative: Resident was assessed by nursing and sent to ACH for further evaluation. The aggressor was placed on assaultive level B and line of sight precautions.

Licensing Specialist spoke with Ms. Barbara McCrory, Chief Administrative Service Officer, regarding ELS Case #0015813. The provider reported incident happened on 8/31/2023 in a classroom. Licensing Specialist reviewed camera footage on 9/6/2023.

Licensing Specialist observed residents sitting at their desk eating a snack, ratio 2:5. Residents were in Ms. Sheena's classroom along with a staff member. Licensing Specialist observed the teacher get up from her desk and walk toward the AO. The residents appeared to be having a discussion with the teacher and staff member.

The AV was sitting behind the AO in the classroom. Licensing Specialist observed the AO laughing and talking with the teacher. The ratio changed to 3:6, a staff member and a resident entered the classroom. AO got up and walked toward the door in the classroom.

AO walked around the teacher toward the AV and started hitting the AV in the head area. Staff members were observed separating the residents, ratio 5:6, other staff members were observed entering into the classroom.

AV was escorted out of the classroom. Licensing Specialist observed blood on the desk where the AV was sitting. The AO was moved to the opposite side of the room.

Once the AV was removed from the classroom, Licensing Specialist observed staff talking with the AO.
