Staff intervened, separating the client ([REDACTED]) from the peer. The Client ([REDACTED]) tried to break the leg off of the chair. The Client ([REDACTED]) then attempted to get a pencil and threatened to stab someone. The Client ([REDACTED]) aggression increased when a male staff entered the room. The Client ([REDACTED]) punched staff with closed fist and swung at staff with closed fist while also threatening to harm him. The client ([REDACTED]) was placed in a child protective position for 1 minute. The client ([REDACTED]) got out of the position and continued to hit staff. Bono Police department was called to the facility at 9:40am. [REDACTED] was transported to the Craighead Juvenile Detention Center in Jonesboro, AR.

Interim Action Narrative: Staff intervened and the residents were separated. Due to aggression resident was placed in a child protective position. Police were called.

Licensing Specialist spoke with Ms. Waynette Banks, Program Director, regarding ELS Case #015797. The provider reported incident happened on 8/31/2023 in Classroom 2. Licensing Specialist reviewed camera footage on 9/5/2023.

Licensing Specialist observed ratio 2:7 in Classroom 2, Big Boys Classroom. Residents were sitting at their desks and the resident was observed walking around the classroom.

9:26 am, Licensing Specialist observed resident being escorted to his seat where he threw a folder at a peer. 9:33 am, resident was observed sitting in the floor with his legs and arms wrapped around a chair. Staff was observed attempting to remove the chair but resident would not let go.

9:35 am, Program Consultant arrived on the classroom hallway. The other residents were escorted out of the classroom. Licensing Specialist observed the resident crawling on the floor, swinging, spitting, and, kicking at staff, ratio 1:1. 9:36 am, resident was observed being placed in a CCP restraint. Licensing Specialist observed resident bucking his head and kicking at staff.

9:38 am, another staff member was observed entering the classroom. Resident was observed dropping to the floor to get out of the restraint. Once released, Licensing Specialist observed resident swinging at staff. Licensing Specialist observed staff member blocking resident's kicks and swings. The nurse arrived, ratio 3:1. A staff member left the classroom, ratio 2:1, and resident was observed sitting in the floor of the classroom.

9:46 am, resident and staff members were observed leaving out the classroom. 9:51 am, Licensing Specialist observed the police walking in the front office. 10:05, Licensing Specialist observed the resident being escorted out the front office, while handcuffed. Ratio 2:1, two police officer were observed.

Licensing Specialist informed that resident has not returned to the facility and will not be able to return.
