Licensing Specialist completed buildings and grounds and observed the following areas: butterfly room, seclusion rooms, quiet room, nurse's station, storage rooms, bedrooms, dining room, courtyard, staff breakroom, and bathrooms.

Licensing Specialist was escorted by Ms. [REDACTED], Director of Quality and Risk Management.

Walking to the building, Licensing Specialist observed the grounds. Licensing Specialist observed parked cars on the lot, the grass was nicely cut, and the shrubs were cut. Licensing Specialist observed a picnic table and trash cans on the grounds. In the lobby, Licensing Specialist observed the August activity calendar for the residents. Licensing Specialist requested the September calendar.

Walking to the PRTF unit, Licensing Specialist saw residents (acute) eating lunch in the dining room. On the PRTF unit, the butterfly room is located by the therapist office it was clean. Licensing Specialist observed a water pitcher at the nurse's station for drinking water. The two seclusion rooms had sufficient lighting and shatterproof light fixture.

The furniture in the day area was clean and in good repair. Bedrooms and bathrooms were neat and clean. Licensing Specialist could smell the aromas of cleaning supplies, housekeeping had recently cleaned the unit. Residents keep their rooms organized. Laundry room has new shelves to store the residents' extra belongings. Clients' rights and the emergency plan were posted by the nurse's station. Stress/Fear Response System is posted on the wall leading to the bedrooms.
