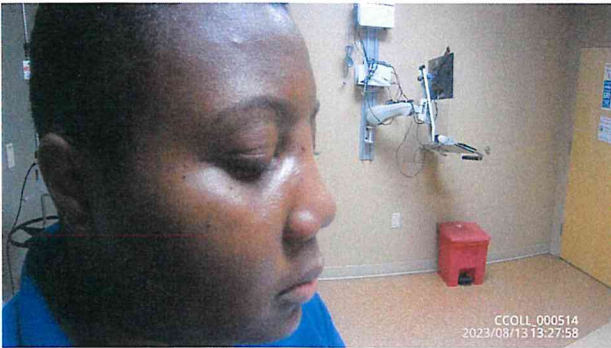

On 08/13/2023 dispatch received a call for a physical disturbance at 1521 Albert involving a female healthcare working and a male residence of the facility. Officers were dispatched to the scene upon their arrival they were notified that the female healthcare worker had already left the scene to receive medical care.

I Officer Kinney went to the Forrest City medical center to speak with the female later identified as Jazzalyn Rodgers. Rodgers stated that residence of the facility were playing competitive basketball which they are not allowed to do, Rodgers and another female employee told the residents to stop and to line up. Rodgers then stated that one of the male identified as [REDACTED], became irrate and began cussing Rodgers and the other employee. Rodger then stated that the other female employee was standing between her and [REDACTED], [REDACTED] then charged the other female pushing her into Rodgers causing both females to fall into a bench.

Rodgers stated that when she was trying to get up from the ground [REDACTED] the struck her in the nose with his fist.

Rodgers received two small laserations and slight swelling of the nose and right eye, Rodgers stated that her glasses were broken during the incident.

Rodgers was informed of the affidavit process and stated that she did want to press charges on [REDACTED]. Rodgers then came to the Forrest City police department and gave a written statement and filed an affidavit.
