She ran into the seclusion room and began to bang her head on the wall and stated that she wanted to kill herself. She was verbally de-escalate by nurse and staff. Once returned to the unit she got a marker and started self-harming with them. She had to be restrained briefly to stop her from self-harming. Patient placed on suicide precautions and on line of sight. Therapist to consult with her to see if any additional precautions are needed and the duration.
