Licensing Specialist observed residents and staff members on the hallway preparing/transitioning for residents to take their medications. This provider reported incident took place during school time.

12:55 pm, Licensing Specialist observed the residents standing in line for their medications with staff members toward the middle and at the end of line. 12:56 pm Licensing Specialist observed a peer being restrained. The resident that was injured was observed talking to a staff member. A peer was observed jumping on the resident with staff standing by him (resident).

Staff member was observed separating the two residents. Other staff members (total of 8) were observed assisting to separate the two residents and keep other residents from participating in the altercation. Licensing Specialist informed that the resident was using racial slurs. 12:57 pm, Licensing Specialist observed resident being taken to the UR Room to be assessed.

Licensing Specialist informed that both residents were placed on assaultive precautions and peer restriction.
