They walked off-campus into an adjacent wooded area. Millcreek personnel notified the Fordyce Police Department of their elopement. FPD located the patients and escorted them back to the facility. Estimated time away from the facility was 30 minutes.

Licensing Narrative: On 9/2/23 clients [REDACTED], [REDACTED], and [REDACTED] eloped from Magnolia Hall living unit. They walked off-campus into an adjacent wooded area. Millcreek personnel notified the Fordyce Police Department of their elopement. FPD located the patients and escorted them back to the facility. Estimated time away from the facility was 30 minutes. Facility visited 9/5/23 and client [REDACTED] interviewed. [REDACTED] stated that he did not have staff/client ratio supervision of 1:1 during this incident. When asked where staff were, "watching other kids". Staff present during incident, Courtland Maddox, interviewed. Mr. Maddox stated that initially client [REDACTED] was 1:1 with staff Alaysia Lucky. Client [REDACTED] kicked cabin door open but remained outside. Staff Lucky was able to talk to client [REDACTED] and [REDACTED] returned inside. Later,

the door to the cabin was still open from being broken by [REDACTED]. Clients [REDACTED] and [REDACTED] who staff Maddox was responsible for supervising, exited the door to the cabin. Staff Maddox exited the cabin, client [REDACTED] walking behind. Staff Maddox remained outside with clients [REDACTED] and [REDACTED] for about 20 minutes, attempting to discourage them from eloping while staff Lucky remained inside with the other clients. Eventually, the 3 clients ran out of sight from Mr. Maddox. Mr. Maddox indicated that staff/client ratio during this incident was 2:7, allowing for 1:1 with client [REDACTED].
