Narrative & Statements

Narrative - Huante, Julian - 09/04/23 10:33:14 AM (Initial)

ON TODAY'S DATE OF 09-04-23, I, OFFICER JULIAN HUANTE WAS DISPATCHED TO THE DELTA FAMILY HEALTH & FITNESS IN REFERENCE TO 3 JUVENILES WHO ESCAPED. MYSELF, PORTLAND POLICE CHIEF CHRISTOPHER RIORDAN, ASHLEY COUNTY DEPUTIES AMADO MONDRAGON, LEVETTE WHITFIELD, AND MICHAEL VORHEASE ARRIVED AT THE FACILITY. I RETRIEVED THE NAMES OF THE JUVENILES ALONG WITH THEIR PERSONAL INFORMATION AND QUESTIONED THE STAFF THAT ALLEGEDLY CHASED AFTER THEM.

ONE OF THE STAFF MEMBERS THAT I SPOKE TO STATED HE SAW THEM GO OVER THE FENCE AND WAS THE FIRST TO GIVE CHASE, HIS NAME IS EDWARD THOMAS. HE STATED HE WAS OUTSIDE WITH A GROUP OF JUVENILES FOR THEIR REGULARLY SCHEDULED OUTSIDE TIME. HE STATED HE BECAME DISTRACTED WITH SOMETHING ELSE WHEN THE JUVENILES DECIDED TO GO OVER THE FENCE AND STATED HE CAUGHT THEM AS THEY WERE CROSSING AND TOLD THEM TO STOP AS THE LAST JUVENILE WAS CROSSING. THEN HE STATED THIS IS WHEN HE GAVE CHASE AND MOTIONED FOR ANOTHER STAFF MEMBER TO FOLLOW HIM.

HE STATED HE SAW THE JUVENILES CROSS HIGHWAY 82 EAST AND HEAD INTO THE WOODS. MYSELF AND CHIEF RIORDAN WENT DOWN THE STREETS THAT WERE ADJACENT TO THE AREA TO ATTEMPT TO CUT THEM OFF. SHORTLY THEREAFTER, DEPUTIES MICHAEL VORHEASE AND AMADO MONDRAGON ASSISTED US WITH ATTEMPTING TO LOCATE THE JUVENILES WITHOUT SUCCESS. WE ALL EVENTUALLY MET BACK UP AT DFC WHERE WE WERE MET BY HAMBURG CHIEF OF POLICE JOHNNY OLIVER WITH HAMBURG OFFICERS NICOLE CARTER, BRANDON KELLEY AND PART TIME OFFICER DANNY LEPIEW.

AT APPROXIMATELY 1:20 PM, AN AMBULANCE UNIT CAME ON THE RADIO AND INFORMED US THAT THEY SPOTTED ALL 3 JUVENILES BACK ON HIGHWAY 82 EAST AND HAVE THEM STOPPED FOR US. SERGEANT NICOLE CARTER ARRIVED ON SCENE FIRST AND ASKED FOR HANDCUFFS TO DETAIN THEM. MYSELF AND BRANDON KELLEY ARRIVED SHORTLY AND PLACED HANDCUFFS ON THE JUVENILES. AFTERWARD, THE JUVENILES WERE TRANSPORTED BACK TO THE FACILITY BY MYSELF AND BRANDON KELLEY WHERE WE MADE SURE THEY WERE SECURE AND SAFE.

AFTER THE JUVENILES WERE RETURNED TO THE FACILITY, ONE OF THEM BY THE NAME OF [REDACTED] STARTED MAKING COMMENTS ABOUT HIS STEP-MOTHER AND HOW SINCE HE WAS 14 YEARS OLD HE WAS BEEN WANTING TO KILL HER. HE ALSO STATED THAT HE IS DUE TO BE RELEASED IN A COUPLE OF WEEKS AND WOULD ATTEMPT TO KILL HIS STEP-MOTHER AS SOON AS HE WAS RELEASED. HE STATED "CONSIDERING IT'S NOT ILLEGAL TO BE WAITING ON YOUR STEP-MOM TO ARRIVE AT HOME WITH A POCKET KNIFE IN YOUR LAP. SAYING YOU WANT TO MURDER YOUR STEP-MOM. I'VE TOLD THE JUDGE! THERESA FRENCH! THAT A BUNCH OF TIMES, THAT I'VE WANTED TO DO IT FOR 3 YEARS!" " I SHOULD'VE BEEN PUT IN A STRAIGHT JACKET! FOR WANTING TO MURDER PEOPLE!"
