Residents were eating dinner, walking around the dorm, and one resident appeared to be having a meltdown by the entrance of the dorm, ratio 3:8. Resident over her ears, and a book in her hand. Resident was sitting.

was sitting at a table eating dinner, with her headphones walked into the common area where resident was sitting.

It appeared that the residents had some sort of verbal altercation/exchange of words. A staff member was observed standing between the two residents. Resident \_\_\_ grabbed a tray and threw the tray in direction of resident \_\_\_ A staff member was observed catching the tray. It appeared that resident \_\_\_ may have stepped wrong when she attempted to hit resident \_\_\_ with the tray. Licensing Specialist observed resident \_\_\_ sitting on the chair rubbing her knee. Ratio 2:1, staff members were observed assessing resident \_\_\_ Resident was observed placing her hands and shirt over her face. Licensing Specialist observed resident \_\_\_ in what appeared to be yelling.

Resident was observed getting out of her chair and charging toward resident . Resident was observed moving out of the way of resident . Licensing Specialist observed resident run into the wall. She was escorted back to the chair where she was observed crying and rubbing her knee.

Staff members were observed each time intervening when resident attempted to attack resident. Staff members kept the residents separated. After resident s second attempt, Licensing Specialist observed the nurse role resident's pants leg and assessed her right knee.
