After receiving consequences (60k focus and placed on assault precautions) for behavior. The client ([REDACTED]) became argumentative and defiant. Client ([REDACTED]) struck the wall with a closed hand. Client ([REDACTED]) injured his 5th metacarpal & knuckle. Client has mild amount of edema to 5th knuckle. Mobile x-ray was ordered. X-ray showed an [REDACTED]. Client was taken to St. Bernard's ER. Client was given a splint for the injury.

Interim Action Narrative: Resident was assessed by nursing, mobile x-ray, and taken to the ER for further treatment. He was placed on 60k focus and assault precautions.

Licensing Specialist spoke with Ms. [REDACTED], Program Director, regarding ELS Case [REDACTED]. The provider reported incident happened on 9/7/2023 in the dining room. Licensing Specialist reviewed camera footage on 9/13/2023.

Licensing Specialist observed resident standing in the doorway of the nursing station. It appeared that the Lead [REDACTED] was talking with the resident. The resident was observed pacing back and forth in front of the nursing station doorway. Licensing Specialist observed the nurse poke her head out of the doorway, ratio 2:1.

Once the resident walked back past the doorway, Licensing Specialist observed the resident move swiftly toward the water fountain. Resident was observed striking the water fountain with closed fist (right hand), ratio 1:1. Licensing Specialist observed resident pacing the dining room. Licensing Specialist observed the nurse come out the doorway from the nursing station. Resident was assessed by the nurse.

Per maintenance, the chair lift has been repaired. Licensing Specialist observed the lift chair. Licensing Specialist informed resident returned from acute care on 9/12/2023.
