**Report Description:** Staff reported that above named resident was in a physical altercation with 4 of his peers after leaving the gym. Staff reported that once back in the dayroom, resident told his peers they were too loud and stood up and began to curse at the residents and a physical altercation ensued. Staff were able to separate the residents. **Actions taken:** upon examination resident was noted to have a knot under his left eye and a small knot on his forehead. Order was obtained for APRN Perry and an order was obtained to send resident to FCMC ER for further evaluation and treatment. **Results:** Assault by unspecified means; contusion of other part of head. **Proper notifications were made. Licensing Specialist spoke with Mrs. Charlotte Lockhart, CEO and Mr. Cliff Williams, Program Director, regarding ELS Case #015974. The provider reported incident happened on 9/7/2023 in 100-A Dayroom. Licensing Specialist reviewed camera footage on 9/12/2023.

Licensing Specialist observed residents sitting in chairs, ratio 2:10. Licensing Specialist observed resident get out of his chair and what appeared to be yelling at his peers and gesturing. Resident was observed sitting back down in his chair. Licensing Specialist observed resident's mouth moving and his peers looking at him.

Residents (two/2) were observed standing up stretching and walking toward the resident that was yelling. Staff observed walking in the direction of the residents and the peer. Residents were observed approaching the peer. Licensing Specialist observed a physical altercation between the peer and residents.

Staff were observed separating the residents from the peer. Licensing Specialist observed residents being separated and directed away from the peer, ratio 7:10. Once residents were separated from the peer, Licensing Specialist observed the peer being escorted out of the day room to be assessed by nursing.
