Narrative & Statements

Narrative - Clark, Justin - 9/10/2023 3:03:59 AM (Initial)

On September 10, 2023 at approximately 2:30 AM, I, Officer J. Clark #275, was dispatched to 600 North 7th Street (Perimeter Behavioral Health) in reference to an attempted suicide.

Upon arrival, I was guided into the facility where I observed the victim, a [REDACTED], to be laying on the floor inside of room #2 with several nurses attending to [REDACTED] appeared to be unconscious but breathing. EMS units with the West Memphis Fire Department then made scene and transported [REDACTED] to the LeBonheur Children's Hospital for further treatment.

I then made contact with [REDACTED] (complainant) who stated that he was making his fifteen minute rounds at 2:00 AM and checked [REDACTED] room and saw [REDACTED] be okay, but when he went back to perform his checks at 2:15 AM he found [REDACTED] on the floor of the room unconscious with a pair of yoga pants double knotted around [REDACTED] neck so tight that they had to be cut off of [REDACTED]. Officer K. Martinez #274 obtained a voluntary witness statement from Ward and the pants were collected as evidence.
