Licensing Specialist spoke with Mr. Clifton Williams, Program Director, regarding ELS Case #016238. The Provider Reported Incident happened on 9/16/2023 on the courtyard. Licensing Specialist reviewed camera footage on 9/20/2023.

Licensing Specialist observed residents from the 300 Hall outside on the courtyard participating in different activities. Licensing Specialist observed resident and a peer throwing a football back and forth. The ratio was 4:15.

The actual incident took place in the corner of the courtyard. Due to the angle of the camera and the darkness of the area, Licensing Specialist was unable to observe the residents in a physical altercation. Licensing Specialist observed staff members running to the area to intervene the physical altercation.

Residents were separated and were walked in two different directions of each other. Another staff member was observed having the other residents line up near the building. Mr. Williams informed Licensing Specialist that residents involved were placed on assault precautions. Resident [REDACTED] was moved to the 100 Hall for safety.
