I made contact with complainant, [redacted] stated victim, [redacted] asked to use the bathroom, and a tech was outside the door. [redacted] stated the patient stated [redacted] drank toilet bowl cleaner that was in the toilet bowl in an attempt to self harm. The nurse went to assess [redacted], and [redacted] was hanging over the toilet, and was feeling nauseous. West Memphis Fire Department was called to the scene. [redacted] was transported to Baptist Crittenden Hospital. I collected a statement from [redacted].
