

Description:

On October 16, 2023, I spoke with McKenna Sherill in regards to the two reports she had filed. There were two separate reports involving 4 different individuals. All individuals involved are in DHS custody and are here from other states. I asked her what the purpose of filing the report was, if it was to document the incident or if it was because the other victim parties wished to pursue charges.

She stated that one victim had no interest in pursuing charges and the report was to document only. She stated that we report did wish to press charges. It is unknown if that was communicated to the reporting officer, but no charges were filed at that time. Both the victim in her case have since been discharged and have returned back to their home state. With all parties being from out of state and in DHS Custody, I will not be able to speak with them.

At this time, with the suspects and victims no longer being present, their DHS status and the fact that they are juvenile, there is nothing further to be done in these matters. These reports will be forwarded to my supervisor for Inactive Case Status Review.
