Primary Narrative By Josh Keyes, 10/05/23 18:43

Phone Report

On October 5th, 2023, at approximately 1830 hours, I, Deputy Josh Keyes, made phone contact with Randy ██████████ in reference to alleged child endangerment.

Mr. ██████████ stated that his granddaughter, ██████████, went with her father, ██████████, during a visitation on the weekend of September 30th and October 1st, 2023. ██████████ returned to 20400 Colonel Glenn Road, the Youth Home on Sunday afternoon after visitation with her father.

██████████ was administered a drug screen that indicated a positive result for THC. The drug screen was administered and recorded by the on site RN, ██████████ which there was no other information for. Mr. ██████████ complained that there was no report of ██████████ drug screen completed by the Youth Home staff.

Mr. ██████████ could not provide any information of the date and time of the incident and only provided a vague statement of "sometime over the weekend". Mr. ██████████ stated that ██████████ has "a long list of drug addictions and he's been in and out of rehab". Mr. ██████████ also could not provide any further information pertaining to the father.

Mr. ██████████ commented that "this is an ongoing legal battle".

I spoke with Anyah from the DHS Hotline and provided details of this report.
