Assisting officers: James 297

On October 6, 2023 at approximately 4:33 p.m., I, Officer Kimbrough 271, responded to 600 N 7th St. in reference to a suicide attempt by one of the patients.

Officers made contact with the complainant, [REDACTED]. [REDACTED] advised that while doing a room check, they found the suspect, [REDACTED] with an elastic headband wrapped around [REDACTED] neck. After getting the headband from around [REDACTED] neck they began to attempt to revive [REDACTED]. [REDACTED] advised that they used an ammonia pack, and at this time [REDACTED] began to cough, but still acted as if [REDACTED] was not okay. [REDACTED] advised that when they attempted to use another ammonia pack, [REDACTED] held her breath.

EMS arrived on scene to access [REDACTED] and transported [REDACTED] to Baptist Crittenden. Photos were taken of [REDACTED] injuries.
