██████████ (suspect), a patient, refused to return to ██████ unit. ██████ stated that ██████ was warned multiple times by staff that ██████ would be physically escorted back to ██████ pod if ██████ did not comply. When ██████ refused to comply, the staff escorted ██████ back to the unit. ██████ stated that ██████ became verbally aggressive at this point. ██████ then charged a nurse at the facility; the team was able to restrain ██████ physically, but while secured, ██████ started kicking the staff. At this point, they had to garb ██████ legs to prevent injury to ██████ and the staff. While staff members were down on ██████ legs, ██████ freed ██████ arm and punched ██████ three times in the back of the head with a closed fist. The ██████ suffered minor injuries, a scratch behind the nurse's right ear. Officers took photos of the ██████ injuries, which are attached to this report.
