### Notice of Serious Incident

**Report Description:** Millcreek reported the following allegation to the Arkansas Mandated Reporter Portal. The report was not accepted for investigation because of a duplicate entry. Referral ID: [REDACTED] [REDACTED] in PRTF placement, reported events alleged to have occurred on 10.05.2023: "The kid made me suck him off. I tried to say "No," but the kid said he would give me clothes, so I said OK, to make him shut up." Clothes were exchanged between the two peers. [REDACTED] indicated that the peer he referred to was [REDACTED] patient in the PRTF setting. Upon receiving the report, [REDACTED] was moved to a different living unit and placed on Close Observation to prevent future occurrences. On 10.11.2023, Millcreek received notification that a report was made by an outside entity and accepted for investigation by [REDACTED]. The report alleged that [REDACTED] woke from sleep to find a penis in his mouth. He was forced to continue to perform oral sex until the peer ejaculated in his mouth. The report also alleged concerns with patient supervision by direct care staff at Millcreek. Referral ID: [REDACTED]

[REDACTED] interviewed. [REDACTED] denied this incident ever took place. [REDACTED] stated that [REDACTED] is saying this because [REDACTED] is afraid [REDACTED] is going to beat him up over some necklaces that [REDACTED] was supposed to give [REDACTED]. [REDACTED] added that [REDACTED] is saying this to get moved closer to his girlfriend who lives on the girl's unit at Millcreek. [REDACTED] repeated that this incident never took place adding that he has a girlfriend at home and is not homosexual. [REDACTED] stated that he has never seen all 3 staff (17 clients at Pine Ridge) leave Pine Ridge at any given time. He stated that staff do take breaks but other staff relieve them. [REDACTED] interviewed. [REDACTED] stated that when this incident took place "Mr. [REDACTED] said he was going to the smoke shack", "[REDACTED] went out back to vape" and "[REDACTED] went to get Taco Bell...I know because I saw the big Taco Bell sack". [REDACTED] stated the incident took around 3-4 minutes. Licensing is not prepared to make a finding as of 10/12/23. Received notification 12/14/23 that maltreatment investigation was unfounded.
