On October 12, 2023, Officer Albert was dispatched to 1521 Albert Street (a behavioral Facility) in reference to one of the residents assaulting a staff member. Upon arrival I made contact with the 16-year-old child [REDACTED] who advised that he was advised that he had to be moved to another hallway and he wasn't moving as fast as the staff member wanted so the staff member ([REDACTED]) started to throw his things and he got upset. He advised that the [REDACTED] grabbed him, and he defended himself. He says he complied with all of his staff's orders and the staff was aggressive with him.

I also made contact with the staff member who was assaulted ([REDACTED]) who advised he told 16-year-old [REDACTED] that he had to move to another hall when he brushed them off by moving slowly. He says he walked into other residents' room waking them up shaking their hands and moving at his own pace. He says he wasn't compliant and became aggressive and he attempted to put [REDACTED] in a restraint, and he assaulted him. [REDACTED] had red marks on his nose and a scratch on his throat area on the left side. [REDACTED] had a red mark on his nose, a scratch on the left side of his head and multiple scratches on the left side of his neck. The facility was advised of the affidavit process.
