Licensing Specialist completed buildings and grounds. The following areas were observed: grounds, dining room, administration building, nurse's station, bedrooms, bathrooms, parking lot, and courtyard.

Licensing Specialist was escorted by Mr. [REDACTED], Program Director. A fire inspection was being completed during the buildings and grounds walkthrough. Licensing Specialist participated in a fire drill due to a test being conducted.

Walking to the building, Licensing Specialist observed parked cars on the parking lot, some flower bushes near the building, nicely cut grass in front of the parking lot, and two flowerpots on each side of the entrance/exit doors. In the lobby area, Licensing Specialist noticed new furniture. Mr. [REDACTED] informed Licensing Specialist that the floors on the stations have been stripped and waxed. The only floors left to be stripped and waxed are the dayrooms on the stations.

Mr. [REDACTED] informed Licensing Specialist the water fountains on the stations have been removed and the residents utilize water coolers/dispensers for drinking water. The shower areas in the bathroom have bathroom mats and the residents have been provided with shower shoes.

On the SRU Hall, Licensing Specialist observed bedrooms and the bathroom. Some bedrooms had three (3) residents to a room and one (1) resident to a room. Licensing Specialist observed Halloween decorations on the hallways leading to the station. Licensing Specialist noticed the four-square lines have been repainted on the courtyard.

Licensing Specialist observed the classrooms on the educational hall. Classroom 1, ratio 2:11; Classroom 2, 3:14; Classroom 3, 3:13; and Classroom 4, 3:13. Licensing Specialist observed staff and residents being escorted to different areas (bathroom and nurse's station).
