Licensing Specialist completed buildings and grounds on EMAC and EMCC. The following areas were observed: grounds, dining room, administration hall, dorms, parking lot, classrooms, and courtyard.

Licensing Specialist was escorted by Ms. [REDACTED] Director of Residential.

Walking to the building, Licensing Specialist observed parked cars and vans on the parking lot. The lawn was well maintained. The courtyard was free of debris. Ms. [REDACTED] informed Licensing Specialist of the last tornado drill, 9/26/2023.

EMAC – Classroom 1, ratio 3:8, Classroom 2, ratio 2:7, and Classroom 3, ratio 2:8. Licensing Specialist observed the dorms: One, Two, Three, and Four. Dorm 2, ratio 1:1. All bedrooms observed were clean and organized. Dorm 4 housekeeping were working during the walkthrough. Dorm 3, there was a speech therapy session taking place, ratio 1:1.

EMCC – Residents were eating lunch when Licensing Specialist completed the walkthrough ratio 5:28. Licensing Specialist observed a resident eating outside of the dining room with a staff member close by. Licensing Specialist also observed residents coming from the bathroom and another resident entering. It appeared that the residents were using the bathroom before returning to class.

Licensing Specialist observed the dorms at EMCC: North, South, East, and the New Dorm. All bedrooms and bathrooms observed were clean and organized. Licensing Specialist observed housekeeping working on the administration hall. Licensing Specialist observed the following documentation on the walls: weekend schedule, emergency escape plan, client's rights, and the zone of regulations.

Ms. [REDACTED] informed Licensing Specialist of the Halloween festivities planned for the residents next week.
