[REDACTED] further states that staff ([REDACTED]) has been instructing him to lie on other staff instead of telling on her. [REDACTED] does state he used staff's phone to text brother. Staff ([REDACTED]) was suspended pending further investigation. [REDACTED] filed.

Licensing Specialist informed that case is still pending. 12/8/2023, Licensing Specialist followed up with investigator for an update. 12/11/2023, Licensing Specialist informed case found unsubstantiated.
