On 10/19/23 at approximately 1617 hours I was dispatched to 2466 S. 48th Street (Perimeter of the Ozarks) for a battery report. Upon arrival I made contact with McKenna Sherrill, the Case Manager. She told me that two patients attacked another patient and they needed to file a report. Sherrill said that we could interview the victim, but the suspects would likely attack us so that they could go to JDC. I identified the victim as [REDACTED]. [REDACTED] told me that she was punched on the side of the head by [REDACTED] on 10/18/23 around 0815 hours while they were going to school. [REDACTED] told me that today on 10/19/23 at approximately 0830 hours [REDACTED] started punching her on the side of the head again. Staff pulled [REDACTED] off of [REDACTED]. After they pulled [REDACTED] off of [REDACTED] a second patient identified as [REDACTED] hit [REDACTED] on the head.

I asked [REDACTED] if she had any injuries. She said her head and right ear hurt. I looked at her head and ear. I couldn't see any injuries on her person. I filed the report and gave the case manager the report number. She told me that they had video of the incidents but they wouldn't release the video without a court order.

11/14 I contacted the Behavioral Center and scheduled an interview with one of the suspects. The reported stated there are two suspects, but one has moved out. An interview is set up for 1pm this afternoon. After I got to the Perimeter Behavioral Center, I found out that the other suspect, [REDACTED] was under Texas DHS custody, so I cancelled my interview with her. I did not reinterview the victim as I did not want to traumatize her again. Looking at the body camera video from that day, the victim also stated that she threw a book at one of the suspects, possibly prompting the suspect to attack the victim. This case will be placed as inactive.
