She said she denied it previously because she didn't know if fingers counted. It should be noted during my interview with she became emotional and started to cry while speaking about what happened.
After taking the initial statement from I contacted my Sgt. who had the on-call detective call me about the incident. Det. Aini called me and I explained what had happened. He then told me he would call me back, and when he did he told me to take the report and that he would not be coming out.
I informed Perimeter no detective would be responding at this time so they made arrangements for to be moved rooms. Perimeter also provided me with a face sheet for the suspect which was turned into my shift complete box. I gave them the report number along with my work email so they could send me a copy of their child abuse hotline report. I went over the process with shift and advised both parties that the moment had stated she was on her way Perimeter from their home in I then ended my contact with both parties.
At that time, I contacted about the incident and let her know what actions the PD was taking. She was also given the report number. She told she was on her way to Perimeter and planned to remove from the facility as she was there voluntarily. I let her know that if she did remove to contact the detective working case Monday morning to let them know as they would need to be able to speak with regarding the incident. After answering her questions to the best of my ability I ended my contact.
Perimeter acknowledge they were made aware about an hour before prior to my arrival. They stated they were completing the hotline while I was on scene and would email the referral number but as of 1630 hours on Sunday October 22, 2023 they had not. Because they did not provide me with a referral number I completed a hotline myself and received confirmation #
As of Wednesday October 25, 2023, my bodycam footage has still not uploaded so I have not been able to review it to see what terms used when referencing bodyparts or the actions of the suspect, and as a result I used the common names for them in my narrative.
