NARRATIVE

OFFICERS WERE DISPATCHED TO THE LISTED LOCATION IN REFERENCE TO A DISTURBANCE CALL. WHILE AT THE LOCATION A STAFF MEMBER ADVISED OFFICERS, SHE NEEDED TO A MAKE A BATTERY REPORT FROM AN INCIDENT THAT OCCURRED EARLIER IN THE DAY.

ADVISED OFFICERS THAT AT APPROXIMATELY 0930 HOURS THIS MORNING A JUVENILE PATIENT (b)(12) WAS HAVING AN ERRATIC EPISODE AND HAD PHYSICALLY ATTACKED SEVERAL STAFF MEMBERS. ADVISED (b)(12) HAD PUNCHED SEVERAL STAFF MEMBERS STRIKING THEM IN THE FACE AND ARM AREA. ALSO STATED HAD THROWN WATER ON THEM.

ADVISED OFFICERS IN AN ATTEMPT TO GAIN CONTROL OF (b)(12) SHE WAS PLACED INTO SEVERAL PHYSICAL RESTRAINT HOLDS. ADVISED WHILE (b)(12) WAS IN A HOLD THE NURSE ADMINISTERED A SEDATIVE SHOT TO HER AND UPON RELEASING FROM THE HOLD (b)(12) BIT ON THE RIGHT FOREARM. OFFICERS OBSERVED WHAT APPEARED TO BE A LARGE BRUISED BITE MARK ON ARM THE BITE DID NOT BREAK THE SKIN.

REFUSED MEDICAL TREATMENT WHILE ON SCENE AND ADVISED SHE WOULD SEEK MEDICAL ATTENTION AT A LATER TIME.

ADVISED OFFICERS SHE WAS GOING TO PRESS CHARGES AGAINST (b)(12). OFFICERS ADVISED TO CONTACT THE PROSECUTING ATTORNEY'S OFFICE TO SEEK WARRANTS.
