Narrative

On Tuesday, October 24, 2023 at approximately 1:35pm I arrived at the Perimeter of The Ozarks, located at 2466 S. 48th Street in reference to an assault/battery report call. Dispatch advised the caller stated one of the residents of the facility had thrown a cup of water on her and it had occurred about ten minutes ago. Dispatch further advised the caller stated the resident was still being violent.

Upon arrival I made contact with the caller, later identified as Carlock, Lanisha ([REDACTED]) outside the main entrance to the facility. Carlock explained one of the residents, later identified as [REDACTED] the stays in the "Green Unit" due to her age being 17 had gotten upset with her. Carlock said this was the first time [REDACTED] ever had a problem with her. Carlock said [REDACTED] started throwing things around and at one point threw a cup of water at her which got her wet.

Carlock said [REDACTED] came towards her and she grabbed [REDACTED] arms to prevent any further issues between her and [REDACTED]. Carlock was upset about what happened between [REDACTED] and her and wished for [REDACTED] to be taken to Juvenile Detention Center. I explained to Carlock that they wouldn't take [REDACTED] just based off what had happened today. I further explained to Carlock that based off what she had explained occurred would closely fit the charge of disorderly conduct due to causing an alarm. I advised Carlock I would document the incident and that if anything else happened to call us back.

I asked Carlock what measures were being made to prevent further issues between her and [REDACTED]. Carlock said they moved her to a different unit in the facility and placed someone else in the Green Unit. I advised Carlock that was probably for the best to help things calm down. I provided Carlock with the incident number, my name and badge number, and phone number to the police department. It should be noted Carlock's job title was Mental Health Tech and she isn't a nurse. It should also be noted the incident that occurred where [REDACTED] was throwing things was originally called in by another person in the facility (Reference incident number: 23-67428) where the call was cancelled by the caller who stated they no longer needed officers to respond. No further information at this time.
