Licensing Specialist completed buildings and grounds. The following areas were observed: grounds, dining room area, butterfly room, nurse's station, lobby, and dayroom.

Licensing Specialist was escorted by Ms. [REDACTED] [REDACTED] Director of Quality and Risk Management. Ms. [REDACTED] informed Licensing Specialist that the facility is in the process of being renovated. The floors will be stripped and waxed. Carpet in the dayrooms and quiet rooms will be pulled and replaced with vinyl flooring.

Licensing Specialist observed staff outside sitting at a picnic table and throwing away trash near the building. Entering the building, the lobby was clean, and the monthly (October) activity calendar was on an easel for display. Some acute male residents were eating lunch in the dining room.

The PRTF residents were on reset due to displaying negative behavior on Monday (10/23/2023) night. Licensing Specialist observed the residents in the dayroom sitting on the floor and on furniture. It appeared that the residents were working on some worksheets (school work). Staff were sitting in the milieu.

Licensing Specialist observed Halloween decorations throughout the building. Ms. [REDACTED] informed Licensing Specialist of the Halloween festivities for the residents that begins on tomorrow. Licensing Specialist requested a copy of the Halloween festivities.
