Narrative - Morgan, Don - 12/13/2023 11:01:41 PM (Initial)

On 12/13/2023 I Officer Morgan received a call from Charles Sigman at Dacus RTC in reference to a juvenile being aggressive and punching Sigman in the face. Upon arrival I spoke with Sigman. He had obvious injuries to the bridge of his nose and his left cheek under his eye. Sigman stated that S1 was screaming and being aggressive towards his peers. Sigman got in between S1 and peers. S1 punched Sigman several times in the stomach and face. This is the second time I have been called out to Dacus RTC for S1's aggressive behavior. I did NOT interview S1 due to him being a minor with his listed guardian not being present. This case will be turned over to the Craighead County Juvenile Department. Nothing further to report at this time.
