Resident and peer were observed horseplaying. Resident was observed kicking her peer in the butt. Program Coordinator observed the resident playing in the peer's hair. The peer was sitting in a chair with the resident standing to her side.

The peer was observed pushing the resident away. It appeared that the peer pushed the resident in the chest area, not in an aggressive manner. No other contact was observed regarding the allegations made.

Program Coordinator is not prepared to leave a finding at this time.
