Narrative - Burgess, Johnathan - 12/19/23 9:23:33 AM (Initial)

ON DECEMBER 19, 2023 AT APPROXIMATELY 1:38 PM, I WAS DISPATCHED TO DELTA FAMILY CENTER ON HWY 82 EAST WHERE THEY HAD A JUVENILE SUBJECT DETAINED ON THE GROUND. WHILE IN ROUTE I SPOKE WITH CHIEF OLIVER AND THE JUVENILE INTAKE OFFICER JASMINE TANKSLEY. UPON ARRIVING I PLACED THE SUBJECT INTO CUSTODY AND DE-ESCALATED THE SITUATION. I THEN STEPPED OUTSIDE AND CONTACTED MRS. TANKSLEY AGAIN WHO STATED THAT SHE WOULD LOOK FOR A DETENTION CENTER TO PLACE [REDACTED]

I THEN RE-ENTERED THE BUILDING AND STOOD BY WITH THE SUBJECT. WHILE STANDING IN THE ENTRANCE TO DFC I SPOKE WITH LASHUNDRRA MONQUIE KESEE AND GOT HER INFORMATION. MANY OF THE WORKERS WERE SPEAKING STATING WHAT HAPPENED. THEY ADVISED THAT [REDACTED] GRABBED MRS. KESEE SHIRT AND WAS PUSHING HER AROUND. THE WORKERS ADVISED THAT BEFORE HE COULD PUNCH MRS. KESEE, THEY TOOK HIM TO THE ROUND AND RESTRAINED HIM. THE JUVENILES CASE WORKER WHO WAS STILL ON SCENE. THE CASE WORKER ADVISED THAT THEY WOULD TAKE THE SUBJECT BACK TO WHERE HE WAS PREVIOUSLY PLACED. THE STAFF WERE SPEAKING AMONGST THEMSELVES STATING SEVERAL THINGS THAT WERE VISIBLY UPSETTING THE CHILD AND HAD THE POTENTIAL TO RE-ESCALATE THE SITUATION.

I THEN CONTACTED MS. TANKSLEY WHO ADVISED THAT I COULD TAKE [REDACTED] TO THE POLICE DEPARTMENT. I THEN TRANSPORTED [REDACTED] TO THE PD. WE THEN WAITED FOR MRS. TANKSLEY TO CALL WITH A PLACEMENT. MRS. TANKSLEY CONTACTED ME AND ADVISED THAT THEY COULD NOT PLACE [REDACTED] AND THAT DELTA FAMILY CENTER AD FILLED OUT AN AFFIDAVIT
